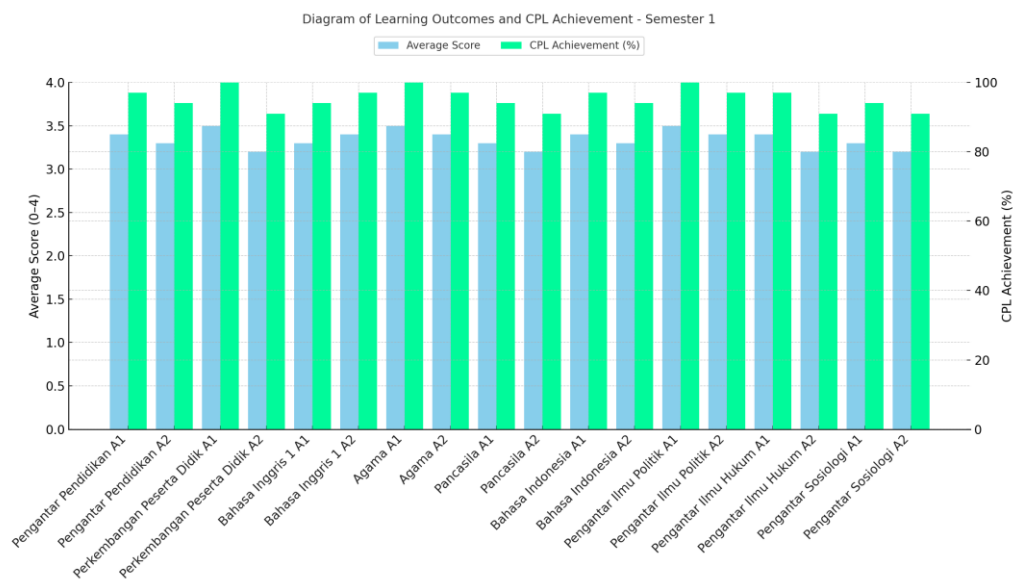
Student Learning Outcomes Matrix PPKn FKIP ULM

Evaluation of learning outcomes is one of the important components in the academic quality assurance system in higher education. The Pancasila and Citizenship Education (PPKn) Study Program, FKIP, Lambung Mangkurat University periodically analyzes the value and learning outcomes of graduates (CPL) to measure the effectiveness of the curriculum and learning strategies applied. This matrix is compiled based on the learning outcome evaluation report for eight semesters and presents information on the average value, percentage of CPL achievement, courses that show superior performance, courses that need improvement, and recommendations for follow-up. It is hoped that this matrix will be a reference for curriculum development, improving the quality of teaching, and academic development of students in the future. 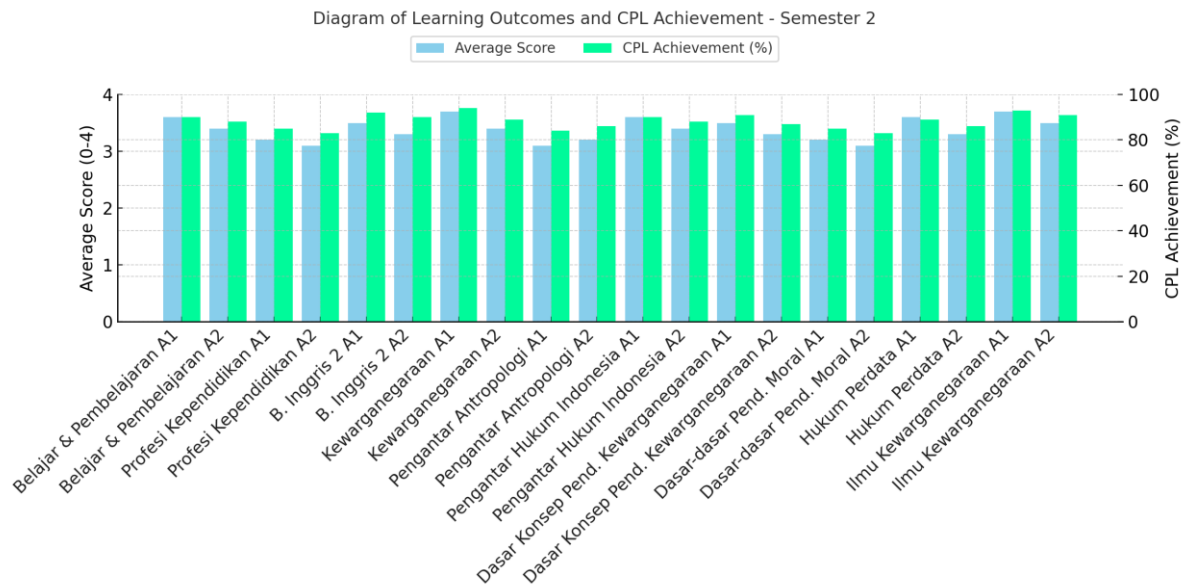

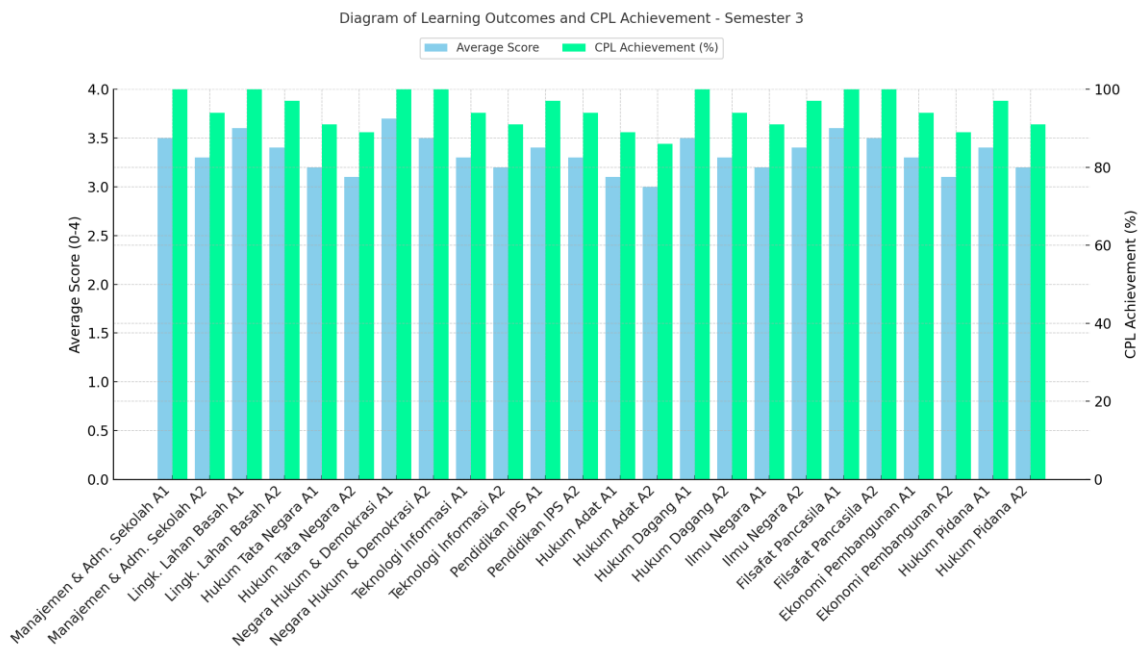

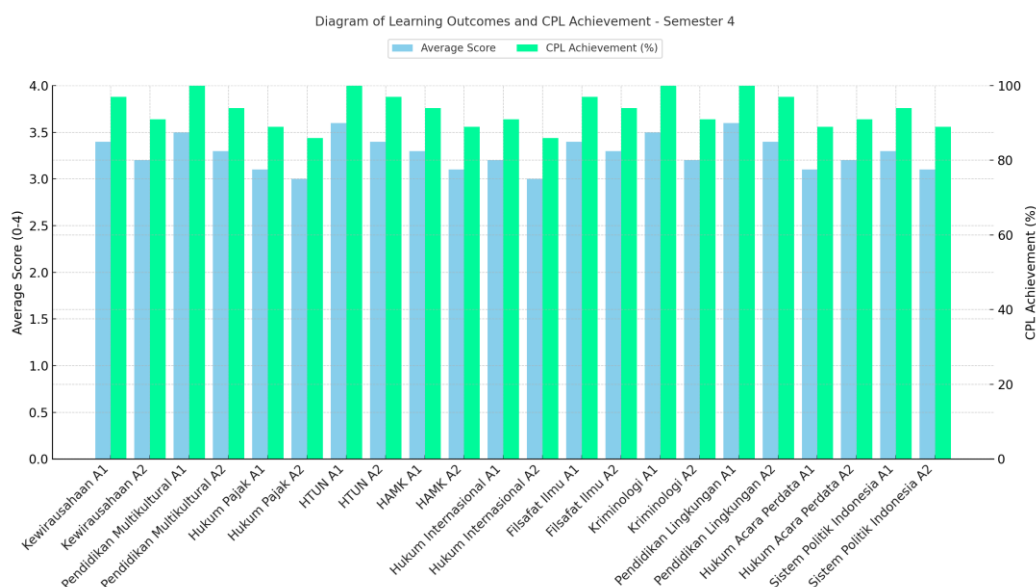

Evaluation diagram of learning outcomes based on grades and CPL for each course.

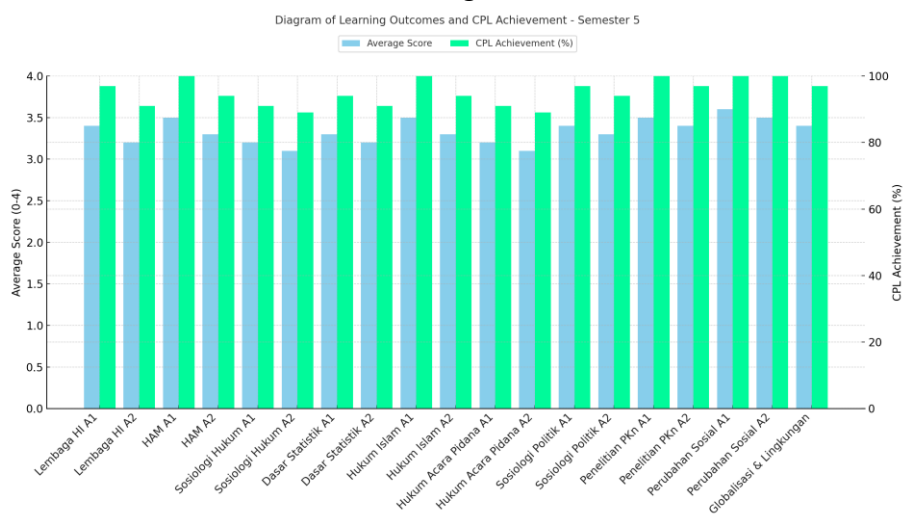

Evaluation diagram of learning outcomes based on grades and CPL for each course.

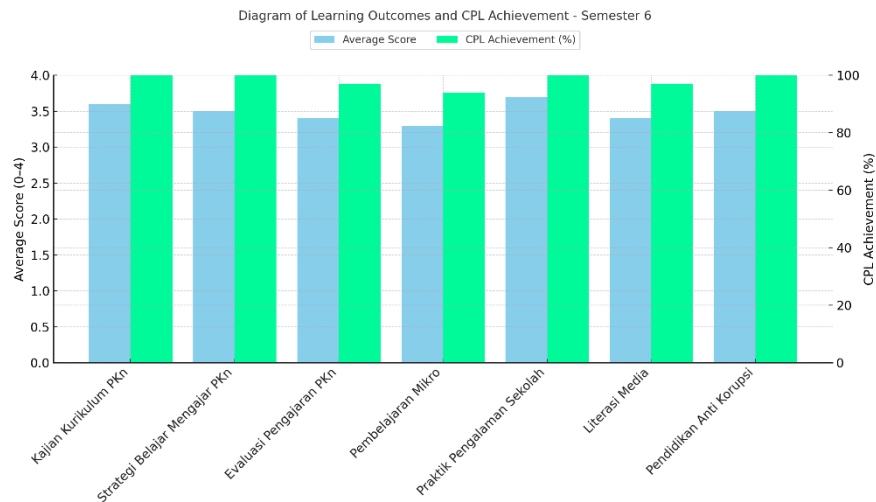

Evaluation diagram of learning outcomes based on grades and CPL for each course.

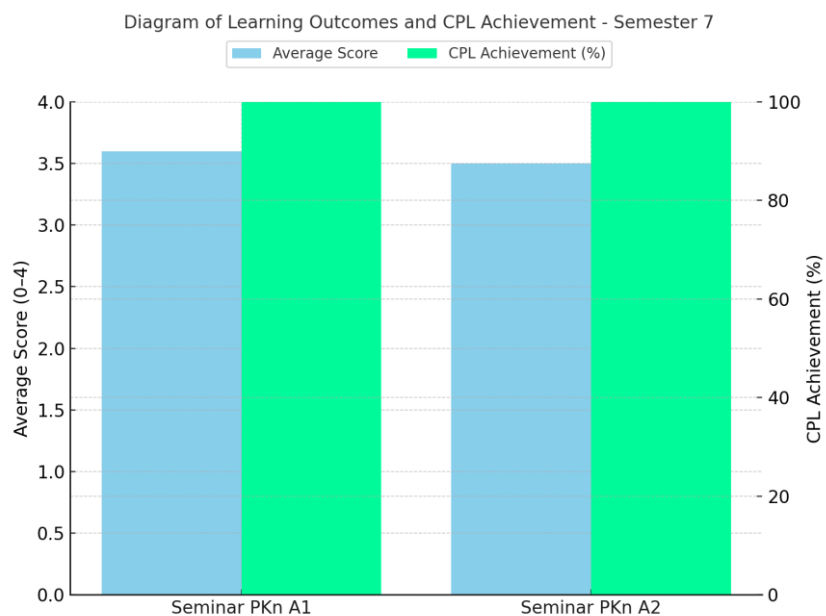

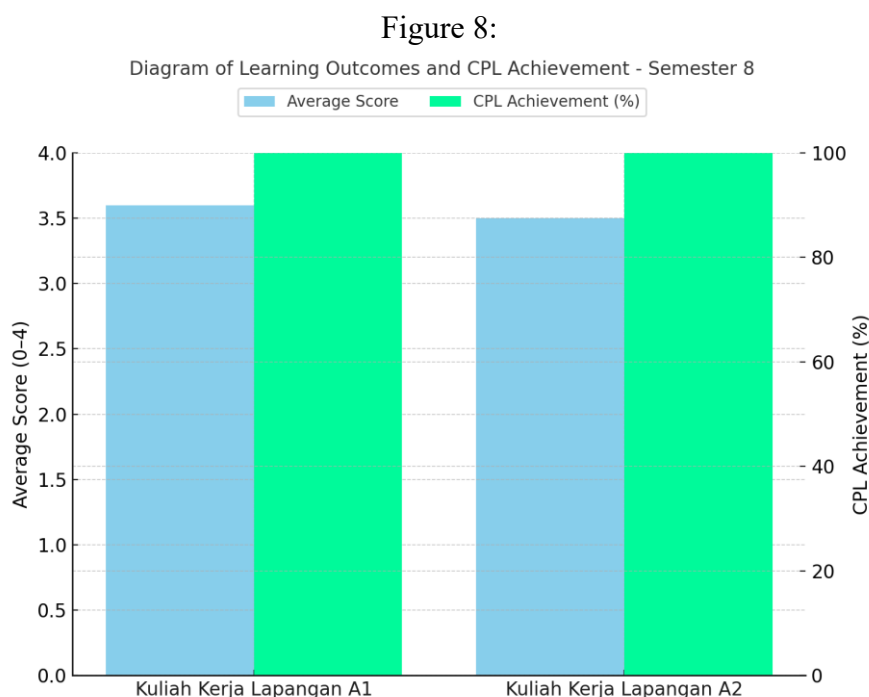
Evaluation diagram of learning outcomes based on grades and CPL for each course.
